The agenda items were deliberated in detail and after having gone through the memorandum placed before the Screening Committee for its consideration, the following decisions were arrived at:-

ITEM NO. I G.I.PIPES:-

During deliberation, it was observed that the rates quoted by L-1 firms are quite competitive, keeping in view the prevailing DGS&D rate contract and the



rates of the previous year. The Committee, thus approved the procurement of GI pipes from L-1 firms, however, in view of budget presently available under NRDWP, the Committee decided to procure G.I.Pipes of smaller diameters i.e. 15 mm to 32mm initially, in view of its consistently high demand. The Committee directed the Engineer-in-Chief to again re-consider and reconcile the balance requirement of larger diameter of GI pipes and put up before the Screening Committee for issue of further orders.

ITEM No.II D.I.PIPES


The Committee deliberated on the issue and in view of L-1 rates being higher than the rates in the neighbouring States and technicalities detailed in the memorandum, decided to defer the requirement for the time being and directed the Engineer-in-Chief to put up the complete case in the next meeting.

ITEM No.III HDPE PIPES

The Committee considered the requirement of HDPE pipes for Killar & Keylong division as submitted by the department and approved its procurement through available HPCOS and DGS&D rate contract.

ITEM No.IV G.I.WIRE:-


The requirement of GI Wire of various IPH Divisions was considered by the Committee. The representative of HPCOS confirmed that the finalization of HPCOS rate contract may take some more time. In view of non finalisation of HPCOS rate contract, the Committee approved the procurement of required quantity from Himachal based DGS&D rate contract holding firm on fixed rate basis as per the conditions of rate contract




ITEM No.IV Grant of Extension to M/s Tirupati Containers Pvt.Ltd.:-


