**MINTUES OF THE MEETING FOR DRINKING WATER SUPPLY SCHEME  
POSED FOR EXTERNAL FUNDING HELD ON 23.08.2014 UNDER THE  
CHAIRMANSHIP OF PRINCIPAL SECRETARY (IPH) TO THE GOVT. OF H.P**

At the outset Chairman welcomed all the participants. After quick round of introduction he explained the reasons for calling the meeting. It was informed that once the schemes are posed for externally funding regular follow up is essential. AD is not aware of the efforts made by the Department thus the meeting.

Superintending Engineer P&I-I was then requested for making presentation on the latest status of the Drinking Water Supply Schemes posed to Govt. of India for external funding for the following schemes:-

1. WSS to Shimla Town from Kol Dam reservoir on River Satluj near Sunni Distt. Shimla (HP).
2. WSS to Nahan Town from Giri River.
3. Aug. of WSS from Sainj Nallah to Village Gharog Ghandal (Phase-I) and Basantpur Kalvi, Nadukhar (Phase-II) in Distt. Shimla (HP).
4. Aug. and Integration of various WSS of Matiana, Kumarsain, Sainj etc in Distt Shimla.
5. Source Level Augmentation of WSS Bharari, Ladhyani, Kot Dehra ,Hatwar etc from River Bias in Tehsil Ghumarwin Distt Bilaspur (HP).

**The following decisions were taken:-**

1. Combined proposal for water supply Scheme Shimla alongwith improvement of distribution system and sewerage system shall be submitted immediately by the IPH department for getting the approval of the state Govt. regarding funding for operation and maintenance costs.
