NOTIFICATION

In pursuance to the letter No.PER(AP)C-B(2)-1/2019 dated 28.12.2021 issued by the Department of Personnel and on the recommendations of the Screening Committee, the Governor, Himachal Pradesh is pleased to order the regularization of the services in respect of the following contractual Assistant Engineer (Civil) in Jal Shakti Vibhag, in the Pay Band of Rs. 15600-39100/-+Rs. 5400/- Grade Pay, with immediate effect, in the public interest:-

The terms and conditions of regularization of the above officer(s) is as under:-

- i) The post(s) of Assistant Engineer (Civil) (Class-I Gazetted), is temporary but likely to continue.
- ii) That on regularization, the officer(s) shall be appointed on the minimum of the time scale and fixation of pay will be done under the provision of rules and orders/instructions in force & issued from time to time.
- iii) The officer(s) shall be on probation for a period of 02 years from the date of joining the post. The period of probation is liable to be extended at the discretion of the Appointing Authority. Failure to complete the period of probation to the satisfaction of the Competent Authority, shall render them liable to be discharged from service.
- iv) The officer(s) shall have to pass the prescribed departmental examination within the probationary period, failing which they shall not be eligible for :-
 - (a) The grant of higher pay scale etc.
 - (b) Confirmation to the service; and
 - (c) Promotion to the next higher post.
- v) The appointment may be terminated at any time by one months notice given either side viz. the appointee or the appointing authority. The appointing authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period by

- making payment of a sum equivalent to the pay and allowances for the period of notice or the un-expired period thereof.
- vi) The officer(s) shall be liable to serve anywhere in the State of Himachal Pradesh.
 - vii) The regularization shall be subject to the verification of character and antecedents of the candidates. If anything adverse is reported against the candidates, this appointment will be treated as null and void.
 - viii) The regularization of the officer(s) shall be subject to the production of Medical Certificate of fitness from the Chief Medical Officer, DDU Hospital, Shimla.
 - ix) The officer(s) shall be required to take an oath of allegiance/faithfulness to the Constitution of India (or make the solemn affirmation to that effect) in the prescribed form.
 - x) The officer(s) shall be required to submit declaration in the prescribed form (in case of married) that he has only one living spouse. In the event of having more than one living spouse, the appointment shall be subject to being exempted from the enforcement of the requirement in this behalf.
 - xi) Other condition(s) of service shall be governed by the relevant rules and orders issued by the State Government from time to time.
 - xii) The officer(s) are required to produce all original certificates in support of their academic/technical qualification, age and reserved class against which they were appointed as such.
 - xiii) If any declaration given or information furnished by the officer(s) proves to be false or if found to have willfully suppressed any material, information, shall be liable for removal from service and such other action as may be deemed necessary.

The above officer(s) are directed to join their duties at his present places of postings within seven days and submit charge assumption report to this Department immediately.
