The Firm/Contractors who downloaded the tender form from the website shall deposit the cost of tender form alongwith with other eligibility criteria in a separate sealed cover upto 5.00 PM on **25/04/2022**. The rates in the tender form will be filled in words and in figures failing, which the tender will be rejected. Conditional tenders or tender received without earnest money will summarily be rejected. The Executive Engineer reserves the right to reject the tender without assigning any reasons.
