The Firm/Contractors who downloaded the tender form from the website shall deposit the cost of tender form alongwith with other eligibility criteria in a separate sealed cover upto **5.00 PM on 10.10.2022**. The rates in the tender form will be filled in words and in figures failing, which the tender will be rejected.
