

"Notice Inviting Tender"



The earnest money in the shape of National Saving Certificate/Time Deposit Account/Saving Account on any of the Post Office in HP/FDR duly pledged in favour of Executive Engineer, JSV, Flood Protection Division, Gagret or exemption if any must accompany with each tender. - The Earnest money in the shape of NSC/Saving account on any of the Post Office in Himachal Pradesh/Time Deposit Receipt of any Nationalized Bank, FDR pledged in the name of Executive Engineer, JSV, Flood Protection Division, Gagret OR certificate of exemption of Earnest Money Deposit.
- The contractor/firms submit the copy of registration of GST, PAN and EPF number.
- The tenders of those contractors who do not deposit the earnest money/all relevant documents in the prescribed manner and conditional tender will summarily be rejected.


