The tender forms can be had from this office on cash payment (non-refundable) on any working day up-to **25-02-2023** till **04:00 PM**. The application for the issue of tender forms will be received up-to **10:00 AM to 4:00 PM** up-to **25-02-2023**.

The tender shall be submitted in two envelopes as prescribed in the conditions given under clause 5 of form PWD-6 as appended with schedule of quantity. The terms and conditions must be accompanied by earnest money as specified below in the shape of National Saving Certificate/Time Deposit Account/Post Office saving account in any of the post office H.P. duly pledged in the name of the XEN JSV Division Jubbhal. Telegraphic/conditional tenders or tender without earnest money will summarily be rejected. The contractors are advised to see site and read the conditions carefully before tendering.

The XEN reserves the right to accept or reject any or all the tenders without assigning any reason thereto. The offer of tender shall be kept open from the date of opening of tender for 120 days.
