


- v. The contractor/firms submit the copy of registration of GST, PAN and EPF number.
- vi. The tenders of those contractors who do not deposit the earnest money/all relevant documents in the prescribed manner and conditional tender will summarily be rejected.
- vii. The contractors/firm must quote their rates in words as well as in figures, failing which their tender case shall not be considered. The contractor/firm will quote his/its offer/rates for each item inclusive of all taxes such as GST, Labour Cess, Royalty etc. and carriage of material.
- viii. The work should be completed in stipulated period.
- ix. In case of sudden holiday on the date of opening of tenders the same will be opened on the next working day.
- x. The offer of the tender shall be kept open for 120 days.
