The application for the same may be submitted to this office on or before **15-07-2023 at 10:30 AM**. The tenders form will be issued on **15-07-2023 upto 3:30 PM** against cash payment (Non Refundable) and tender form will be submitted to this office **17-07-2023 upto 11:00 AM** and same will be opened on same day i.e **17-07-2023 at 11:30 AM**. Telegraphically tenders and tender without earnest money shall not be entertained. The earnest money must accompany in the shape of FDR Nationalized bank duly pledged in the name of Executive Engineer, Jal Shakti Division, Shahpur. 5. The Executive Engineer shall have right to accept or reject any or all the tenders without assigning any reason.
6. Telegraphic, e-mailed or tenders through Fax shall not be accepted.
7. Postal delay shall not be responsibility of the department and late received tenders shall not be entertained.
8. If opening day is a holiday, the tenders shall be opened on next working day at the same time.
9. Tenders of contractors having two or more works in hand or whose performance for execution of similar works has not remained satisfactory under this Division/Jal Shakti Department, are liable to be rejected.
