"NOTICE INVITING TENDER"

Sealed item rate tender on form PWD/IPH 6 & 8 are hereby invited by the **Executive Engineer Jal Shakti Division Sarkaghat** on behalf of the Governor of Himachal Pradesh for the work from the appropriate approved and eligible contractors/firms enlisted in Jal Shakti Vibhag (H.P.) so as to reach in his office on or before dt. **04-12-2023 upto 11.00 A.M** and will be opened on the same day at **11.30 A.M.** in the presence of the intending contractors/firms or their authorized representatives who may be present at the time of opening of Tender. The application for issue of tender form will be received along with cost of tender form upto **02-12-2023 till 1:00 P.M.** The tender forms are also available for down loading on department website "www.hpiph.org" and the cost of form should be in the shape of D.D in favour of **Executive Engineer Jal Shakti Division, Sarkaghat** or in cash, which should be submitted with the tender failing which tender will not be opened. The date of sale / receipt and opening of tender shall be considered as next working day if holiday happens of above specified date.

The earnest money (unless exempted) in the shape of National saving certificate / time deposit account and Post Office Saving Bank Account in H.P. duly pledged in the name **of Executive Engineer Jal Shakti Division Sarkaghat** must accompany with each tender. The tender of the contractor who do not deposit the earnest money in the prescribed manner shall be summarily rejected. Conditional tenders /tender without earnest money will summarily be rejected. However the Executive Engineer reserves the right to reject any or all the tenders without assigning any reasons. The offer of the tender shall be kept open for 120 days .1% labour cess shall be deducted from every running bill in addition to security, income tax and sale tax.

4. The firm/contractor shall submitted EPF/ESIS registration in case the same is not available at the time of tender it should be submitted before commencement of any work awarded to him/her failing which no work will be awarded.
5. The firms/contractors have to submitted the affidavit specifying that the benefit availed under earnest money exemption has not been exhausted so far. Any wrong submission in the matter will directly lead to cancellation of your tender. In case the contractor fails to submitted the required affidavit then he has to submit the earnest money.
6. The contractor must quote their rates in words as well in figures. Failing which their tender form shall not be considered.
7. The conditional or single tender will be rejected.
