4. The contractor / firms are required to quote their rates of each item clearly both in words as well as in figures, failing which the undersigned reserves the right to accept / reject any or all tenders.
5. Other Terms and Conditions shall be as per DNIT of each Job which can be seen in Jal Shakti Division office at Baddi between **10.00 AM to 4.00 PM** on any working days.

6. The tenders of the contractors/firms who fail to fulfill the eligibility criteria will be summarily rejected.
7. The undersigned reserves the right to accept/reject/cancel any tender without assigning any reasons thereof.
8. Certificate of contractor **Registration** with Himachal Pradesh Jal Shakti Vibhag in the appropriate class or the latest renewal thereof.
9. Copy of **PAN** Number, **GST** registration and latest annual **ITR** for the current assessment year **2023-24** thereof.
10. The contractors/firms shall submit a copy of **EPF / ESIS registration** in case the same is not available at the time of tender, it should be submitted before commencement of any work awarded to him/her failing which no work will be awarded.
11. The **Earnest money** in the shape of National Saving Certificate / Time Deposit Accounts / Saving account in any of the Post office in Himachal Pradesh duly pledged in favour of the Executive Engineer, JSV Division, Baddi must be accompanied with each tender. Conditional tenders and the tenders received without earnest money will summarily be rejected.
12. If **exemption** of Earnest Money ensure the correctness of information supplied by the contractor about number of tenders in which he has participated and total value of their EMD involved, contractor will have to furnish **an AFFIDAVIT from Notary or 1st Class Magistrate** stating that he has participated in such number of tender and value of earnest money involved thereof. In case the bidder fails to submit the required affidavit then he has to submit the earnest money.
