The latest Income Tax and Sale Tax clearance certificate along with the copy of PAN , GST number, Contract Labour License, Satisfactory completion of such job Certificate/ Experience certificate, EPF Registration certificate, Registration of agency and service tax registration be submitted physically at the time of sale of tender, failing which no tender form will be issued to any contractor. otherwise tender will summarily be rejected.
3. The agency should follow the criteria of qualification of the outsourcing staff is be provided by the contractor as per instructions/ norms fixed by the HP Govt.
