The tender documents will be processed only after fulfillment of following conditions and eligibility criteria.

1. Valid sale tax registration and clearance certificate/*GST No.*
2. Valid Pan Number and income clearance certificate.
3. The earnest money should accompany with the tender document in the shape of National Saving certificate/DAC of any Post office of H.P. duly pledged in the name of Executive Engineer, I&PH Division Rampur.
4. All the necessary documents such as enlishment/renewal of registration shall accompany with the application for obtaining the tender documents.
5. The conditional tender will summarily be rejected. The undersigned has right to accept or reject one or all the tender without assigning any reason.
