The earnest money in the shape of National Saving Certificate/Time Deposit account and Post Office saving account in any Post Office in Himachal Pradesh duly pledged in favour of the Executive Engineer, I&PH Division, Rohru must accompany each tender. The contractor who has obtained exemption for depositing earnest money must attach a copy of exemption documents with their offer. The conditional tender and tenders received without earnest money will be summarily rejected. If holiday declared by the Government on the above date due to some reason, the tender shall be received and opened on the next working day. The Executive Engineer reserves the right to reject the tenders without assigning any reason. The tender form will only be issued on the production of registration certificate in the prescribed manner. The tender documents sent should be in two sealed cover in prescribed manner. The contractors are advised to see work site and read the conditions carefully before tendering. The offer of the tender shall be kept open from the date of opening of tender is 120 days.
