He shall also intimate the name of persons who are working with him in any capacity or are subsequently employed by him and who are near relative to any Gazetted officer in the Jal Shakti Vibhag. Any breach of this condition by the contractor would tender him liable to be removed from the approved list of contractors of this Department.
22. The contractor shall give a list of non-Gazetted HP PWD / Jal Shakti Vibhag employees related to him. No engineer of Gazetted rank of other Gazetted Officer employed in engineering administrative duties in Engineering Department of the Govt. of HP is allowed to work as a contractor for a period of two years of his retirement from Govt. Service, without the previous permission of the Govt. of HP. This contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of the Govt. of HP as aforesaid before submission of the tender of engagement in the Contractor's service.
23. Tender for a work in HP shall remain open for acceptance for a period of 120 days from the date of opening of tenders.
24. Contractor exempted from payment of earnest money/Security deposit individual cases should attach with the tender as attested copy of the Chief Engineer's letter exempting them from the payment of earnest money and security deposit and should produce the original whenever called upon to do so.
25. The tender for the work shall not be witnessed by a contractor or contractors who himself/ themselves has/have tender or who may and have for the same work. Failure to observe these conditions would render Tenders of the contractors tendering as well as witnessing the tender liable to summary rejection.
26. While quoting the rate in the schedule of quantities the work "ONLY" should be written cost following the Amount and it should not be written in the next line.
27. In case the original tender of the successful tender is on plain paper it should be drawn up by HP. IPH Contract for signature of the contractor and in the event of letter's refusal to sign. His earnest money shall be forfeited.
28. The contractor shall submit a list of the works which are in hand/progress.
29. over writing in the tender is strictly forbidden and correction if any should be initialed. Tender containing doubtful figure shall be rejected.
30. The tender shall sign each page of the tender form.
31. The contractor should obtain permission from the Executive Engineer for extracting stones from road side or approved quarries and ` 1400/- hundred cum will be recovered from him on account of royalty charges for the stones quarried within the acquired width in the road, the royalty for stones quarried beyond the acquired width of road, shall be paid directly by contractor to the concerned department/owner.
32. The contractor shall submit a list of work which is in progress or in hand.
