Earnest money amounting to **Rs.16,500/-only.**
10. Account/Saving Bank Account/Post Office Saving Bank Account of any Post office in HP. Duly pledged in power or engineer in charge should accompany each tender and each tender is to be in a sealed cover subscribed. Tenders for above work and addressed to the Divisional Office Irrigation & Public Health Division **Sarkaghat in Tehsil Sarkaghat, Distt, Mandi, (Himachal Pradesh).**
11. The tenders of those contractors who do not deposit the earnest money in the prescribed manners will summarily be rejected.
12. The contractor whose tender is accepted, unless exempted will be required to furnish by way of security deposit for the due fulfillment of his contract, such sum as will amount.
 - i. **In the case of work costing upto Rs. 2,00,000/- @ 10% of the tendered amount of the work.**
 - ii. **In the case of work costing more than Rs. 2,00,000 and upto Rs. 5,00,000 @ 7.5%**
 - iii. **In the case of work costing more than Rs. 5,00,000 Lacs to 50,00,000 lacs. 5%**
 - iv. **In work costing above Rs. 50,00,000 @ 2.5% with out any limit.**
The security deposit will be collected

13. The acceptance of a tender, will rest with the Executive Engineer, Who does not bind him self to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received, without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who respect to canvassing will be liable to reject on.
14. All rate shall be quoted on the proper form of the tender alone.
Item rate tender containing percentage below/ above will be similarly rejected.
15. On acceptance of the tender, the name of the accredited representative (s) of the contractor or who would be responsible for taking instructions from the Engineer-in-Charge shall be communicated to the Engineer-in-Charge.
16. Special case should be taken to write the rates in figures as well as in words. and the amount in figures only in such a way that interpolation is not possible. The total amount should be written both in figures and in words. In case of figures, the word 'Rs' should be written before the figure for 'Rupees' and word 'P' after the decimal figures, e.g. Rs. 2.15 P and in case of words, the word 'rupees' should precede and the word 'Paise' should be written at the end. Unless the rate in whole rupees and followed by the word 'only' it should invariably be up to decimal places.
17. The Governor of HP does not bind himself to accept the lowest or any tenders and reserves to himself the right of accepting the whole or any part of the tender and the tenders shall be bound to perform the same at the rate quoted.
18. Sales Tax or any other tax on material in respect of this contract shall be payable by the contractor and Govt. will entertain any claim whatsoever in this respect.
19. The contractor must produce income tax clearance certificate before the tender can be sold to him.
20. The contractor shall not be permitted to tender for work in the HP PWD/IPH Circle (responsible for award and execution of contractors) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive). He shall also intimate the name of persons who are working with him in any capacity or are subsequently employed by him and who are near relative to any gazetted officer in the IPH Department. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
21. The contractor shall give a list of non- gazetted HP PWD /IPH employees related to him. No engineer of Gazetted rank of other Gazetted Officer employed in Engineering administrative duties in an Engineering Department of the Govt. of HP is allowed to work as a contractor for a period of two years of his retirement from Govt. Service, without the previous permission of the Govt. of HP. This contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission of the Govt. of HP as aforesaid before submission of the tender of engagement in the contractor's service.
22. Tender for a work in HP shall remain open for acceptance for a period of 120 days from the date of opening of tenders. Contractor exempted from payment of earnest money/Security deposit individual cases should attach with the tender as attested copy of the Chief Engineer's letter exempting them from the payment of earnest money and security deposit and should produce the original whenever called upon to do so.
23. The tender for the work shall not be witnessed by a contractor or contractors who himself/ themselves has/have tender or who may and have for the same work. Failure to observe this conditions would render tenders of the contractors tendering as well as witnessing the tender liable to summary rejection.
24. While quoting the rate in the schedule of quantities the word "ONLY" should be written cost following the amount and it should not be written in the next line.
25. In case the original tender of the successful tender is on plain paper it should be drawn up by HP. IPH Contract for signature of the contractor and in the event of contractor's refusal to sign. His earnest money shall be forfeited.
26. The contractor shall submit a list of the works which are in hand/progress.
Over writing in the tender is strictly forbidden and correction if any should be initialed. Tender containing doubtful figure shall be rejected.
27. The tenderer shall sign each page of the tender form.
The contractor should obtain permission from the Extracting Engineer for extracting stones from road side or approved quarries and Rs. 1400/- hundred cum will be recovered from him on account of royalty charges for the stones quarried within the acquired width in the road, the royalty for stones quarried beyond the acquired width of road, shall be paid directly by contractor to the concerned department/owner.
28. The contractor shall submit a list of work which are in progress or in hand on the performa as below.
