27. While quoting the rates in the schedule of quantities word "ONLY" should be written following the amount and it should not be written in the text line.
28. In the original tender of the successful tender is on plain paper it should be drawn up by IPH Department contract for signature if the contractors and in the event of letters refusal to sign his earnest money shall be forfeited.
29. The contractor shall submit a list of the works which are in hand /progress.
30. Overwriting in the tender is strictly forbidden and correction if any should be initialled tender containing doubtful figure shall be rejected.
31. The tender shall sign each page of the tender form.
