4. The intending contractors/ firms are requested to see the site of work before submitting the tender.
5. The rates of material to be issued by the department will be applicable only upto the validity period of tender. Thereafter prevailing market rates/ store issue rates, at that time, whichever is maximum, shall be charged/ recovered.
6. All the tenders must be accompanied with earnest money in the shape of NSC/Time deposit account and Post Office Saving Bank Account in any of the Post office in HP duly pledged in favour of the undersigned. The contractors exempted from payment of earnest money/ Security deposit in individual cases should attach with the application and attested copy of the letter exempting them from the payment of Earnest Money and security deposit. They shall submit an affidavit regarding not to utilize the exempted limit.
7. The application form should contain the documents i.e. copy of valid enlistment and renewal certificate, Earnest Money, GST No. PAN No. registration and latest annual income tax return.
8. The tender form will not be issued to the defaulter contractors.
9. Contractors shall have registration in Employees Provident Fund Organization (EPFO) for EPF No. before award of work.
10. The offer shall remain valid up to 120 days after the opening of the tenders.
