General Conditions.

- 1 The rates are F.O.R. at site of work i.e. Kullu town , under I&P.H. Division Kullu H.P. and shall be inclusive of all tax , packing, transportation charges with in leads and lifts.
- 2 The Appliances / Equipments shall have to be arranged from manufacturer or his authorised dealers who possess valid certificate of manufactures/dealership having ISO certification of the manufactuering of equipments, chemicals etc. which shall be attached with the bill of cost. If contractor himself is not manufacturer or authorised dealer in that case he will have to associate him with manufacturer or authorized dealer and will furnish an affidavite for same before award of work.
- 3 All the equipment shall confirm to the relevant BIS specifications wherever applicable and in its absence to any accepted National/ International standards.
- 4 The third party inspection of goods shall have to be carried out by some Approved firm through and each consignment shall contain third party inspection note before dispatch of goods at the cost of firm/supplier.
- 5 The Contractor/ firm shall forward a copy of supply order/indent placed by it for the supply of Lab equipments/ Chemicals on the manufactures/ authorized dealers of such items to the consignee within 30 days afte issue of the letter of intent/ award by the Engineer-in-Charge. The copy of supply order/ indent to the consignee should also accompany the dealership certificate of the dealer for the Lab Equipments/ Chemicals/ glass ware in case the such equipments /chemicals are arranged form the authorized dealer

- 6 The contractor / firm shall arrange operation and maintenance training to the operating staff for the laboratory equipment without extra cost for a period of 1 Month which shall be considered as testing period.
- 7 The general specifications of work shall conform to Punjab PWD/HPPWD specifications as per direction of the Engineer-in-charge.
- 8 All the equipments shall be guaranteed against any manufacturing defect and its performance for a period of 12 (twelve) months from the date of installation . Any defect, if noticed within the stipulated period shall be rectified by the firm at its own cost within 15 days of bringing the same to its notice , in case contractor/firm do not replace the same with in said period then department shall deduct such amount from the security of contractor . Minimum 5% amount shall be with held for successful performance of equipments for period of one year and the said amount shall be released after the expiry of the guarantee period.
- 9 Security, Income tax,GST , labour cess and any other statutory deduction as applicable will be deducted from each bill as per latest Govt.amendments.
- 10 Nothing shall be paid for defective/incomplete work/rejected materials.
- 11 The cost of employer provident fund (EPF) & employer state insurance (ESIC) shall be borne by the contractor. Deposit of the same will be responsibility of firm/contractor and department will reimburse the paid EPF separately on production of required document.
