- All the tenders must be accompanied with earnest money in the shape of NSC/Time deposit account and Post Office Saving Bank Account in any of the Post office in HP duly pledged in favour of the undersigned. The contractors exempted from payment of earnest money/ Security deposit in individual cases should attach with the application and attested copy of the letter exempting them from the payment of Earnest Money and security deposit. They shall submit an affidavit regarding not to utilize the exempted limit.
