The notice inviting tender's alongwith schedule of quantity are on the Department website "www.hiph.org" which can be down loaded. The Firm/Contractors who downloaded the tender form from the website shall deposit the cost of tender form alongwith with other eligibility criteria in a separate sealed cover upto 5.00 PM on **17/01/2020**. The rates in the tender form will be filled in words and in figures failing, which the tender will be rejected. The earnest money in the shape of FDR/ National Saving Certificate duly pledged in favour of the Executive Engineer IPH Division Dharampur Bharari. Conditional tenders or tender received without earnest money will summarily be rejected. The Executive Engineer reserves the right to reject the tender without assigning any reasons.
