HP IPH Deptt. Tender Notice

Sealed item rate tenders on forms No. 6 & 8 are hereby invited by the Executive Engineer, **I&PH Division Nalagarh**, District Solan (HP) for the following works from the approved and eligible contractors enlisted with HP I&PH Department, so as to reach in this office on or before **31-01-2020 up to 11:00 AM**. The tender will be opened on the same day **at 11:30 AM** in the presence of intending contractors or their authorized representatives who may wish to be present. The tender documents can be had from above office against cash payment (Non-refundable) up to **30-01-2020 up to 4: 00 PM**. The tender documents can also be downloaded from the departmental website www.hpiph.org, and for such downloaded tender documents cost of form shall be deposited (in cash) on the day of opening of tenders before **11:00 AM**. The tender documents sent should be in **sealed cover** in prescribed manner. The tender documents will be processed only after fulfillment of following conditions and eligibility criteria:-

- 1 The tenderer should have a valid income tax and sales tax registration.
- 2 The earnest money in the shape of small saving instruments, or Fixed Deposit Receipt duly pledged in favour of Executive Engineer, I&PH Division Nalagarh or certificate of exemption of earnest money deposit. In the event of said exemption, an affidavit regarding No. of tenders in which he/they have participated & total value of their earnest money involved be submitted with the tender documents. In case, he/they give false information, he /they will be liable to be black listed.
- 3 Certificate of registration with I&PH Department in appropriate class and latest renewal thereof.
- 4 The offer of the tender shall be kept open for 120 days.
- 5 If there happens to be a holiday, the tenders will be opened on the next working day.
- 6 The bidder should satisfy Engineer-in-charge that the tender of contractor/ firm who have already two or more works awarded / in-complete in hand under this Division and if the works have been delayed, shall not be considered and will summarily be rejected at the time of opening of tenders.
- 7 Contractors shall have registration in Employees Provident Fund Organization (EPFO) for EPF No. before award of work.
- 8 Not more than two (2 No.) tender forms shall be issued to one contractor / firm.
