5. The contractors should quote rates in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite total be given.

When a contractor signs a tender in an Indian language, the percentage above or below of the tendered amount in the case of PWD form No. 7 and the total amount tendered in the case of PWD form No. 8 and 12 should also be written in the same language.
