NOTICE INVITING TENDER**



The application for the same may be submitted to this office on or before **19.08.2019 at 1:30PM**. The tender form will be issued on **19.8.2019. up to 3.30 PM** against cash payment (Non refundable) and same will be opened on next working day i.e **20.08.2019 at 11.30AM**. Telegraphically tenders and tender without earnest money shall not be entertained. The Earnest Money must accompany in the shape of FDR Nationalized Bank duly pledged in the name of Executive Engineer I&PH Division Nagrota Bagwan. The tender of the contractor who do not deposit the earnest money in the prescribed manner shall be summarily rejected. The offer of the tenders should remain valid for acceptance upto 120 days.

Terms and Conditions:-

1. The contractor/firm shall attach the copy of following documents with tender document:-
Enlistment/Latest renewal of registration with IPH Department .
- (i) Reference of earnest money deposit or exemption letter thereof issued by the competent authority without which tenders shall be summarily rejected .
- (ii) Copy of Registration under GST ,latest income tax clearance certificate, copy of PAN etc.
2. The Executive Engineer shall have right to accept or reject any or all the tenders without assigning any reason.
3. Telegraphic-mailed or tenders through Fax shall not be accepted.
4. Postal delay shall not be responsibility of the department and late received tenders shall not be entertained.
5. If opening day is a holiday, the tenders shall be opened on next working day at the same time.
6. The contractor is eligible for maximum of two jobs ,if any contractor applies for more than two jobs application for first fist two jobs in order of Sr.No. will be considered only and remaining will be rejected
7. The contractor will be responsible for watch and ward of material at site of work
8. Tenders of contractors whose performance for execution of similar works has not remained satisfactory under this Division/HPI&PH Department are liable to be rejected


