(unless exempted)** must accompany each tender in the shape of National saving certificate in any post office in Himachal Pradesh duly pledged in the name of Executive Engineer Jal Shakti Division, Karsog and each tender is to be in a sealed cover subscribed tender for above work and address to the Executive Engineer Jal Shakti Division Karsog.
