  - 22 The contractor shall not be permitted to tender for 320work in HPIPH Circle responsible for award and execution of contract in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive). He shall also intimate the name of persons who are working with him in any capacity or are subsequently employed by him who is near relative to any gazetted officer in HP Jal shakti Vibhag in the Ministry of works, housing and rehabilitation. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
  - 23 The contractor shall give a list of non- gazetted HP Jal shakti vibhag employee related to him. No engineer of Gazetted rank or other Gazetted Officer employed in Engineering /administrative duties in an Engineering Department of the Govt. of HP is allowed to work as a contractor for a period of two years of his retirement from Govt. Service without the previous permission of the Govt. of HP. The contract is liable to be cancelled if either the contractor or any of his employee is found at any time to be such a person who had not obtained the permission of the Govt. of HP as aforesaid before submission of the tender of engagement in the contractor's service.
  - 24 Tender for a work in HP shall remain open for acceptance for a period of 120 days from the date of opening of tenders.
  - 25 Contractor exempted from payment of earnest money/Security deposit in individual cases should attach with the tender an attested copy of the Chief Engineer's letter exempting them from the payment of earnest money and security deposit and should produce the original whenever called upon to do so.
  - 26 The tender for the work shall not be witnessed by a contractor (s) who himself/ themselves has/have tendered or who may tender for the same work. Failure to observe this condition would render tenders of the contractors tendering as well as witnessing the tender liable to summarily rejected.
  - 27 While quoting the rate in the schedule of quantities the word "ONLY" should be written cost following the amount and it should not be written in the next line.
  - 28 In case the original tender of the successful tender is on plain paper it should be drawn up by HP. Jal shakti Vibhag Contract for signing of the contractor and in the event of letter's refusal to sign his earnest money shall be forfeited.
  - 29 The contractor shall submit a list of the works which are in hand/progress.
  - 30 Over writing in the tender is strictly forbidden and correction if any should be initialed. Tender containing doubtful figure shall be rejected.
  - 31 The tenderer shall sign each page of the tender form.
