The tender will be opened on the same date at **11:30 AM** in the presence of contractors or their authorized representative who may wish to be present. The tender form can be had from this office against the cash payment/IPO/DD (Non refundable) on any working day upto **07.07.2021 till 3.00 PM**. If the date of opening happens to be a holidays the tender will be opened on next working day at the same time. The draft notice inviting tender can also seen on the website www.hpiph.org. The firms/contractor who download the tender form from the website or upload through e-tendering system shall have to deposit the cost of tender form at the time of submitting of the tender in the shape of IPO/Bank Draft only. The tender should accompany earnest money in the shape of National Saving Certificate/time deposit account of any of the Post Office/Nationalized Bank in HP dully pledged in favour of the Executive Engineer IPH Division Karsog. The conditional/ambiguous/telegraphic tenders or tender by fax shall not entertain/ considered without earnest money in any case.
