**NOTICE INVITING TENDER**

Sealed item rate tender on form PWD/IPH 6& 8 are hereby invited immediate by the Executive Engineer IPH Division Sarkaghat on behalf of the Governor of Himachal Pradesh for the work from the appropriate approved and eligible contractors/firms enlisted in I&PH (H.P.) Department so as to reach in his office on or before dt. **30-06-2018 upto 11.00 A.M** and will be opened on the same day at **11.30 A.M.** in the presence of the intending contractors/firms or their authorized representatives who may be present at the time of opening of Tender. The application for issue of tender form will be received along with cost of tender form upto **29-06-2018 till 4:00 P.M.** The tender forms are also available for down loading on department website "**www.hpiiph.org**" for which the cost of tender form shall have to be deposited upto **29-06-2018 till 4:30 P.M.**

The earnest money (unless exemption ) in the shape of National saving certificate / time deposit account and post office saving bank account in H.P. duly pledged in the name of Executive Engineer IPH Division Sarkaghat must accompany with each tender. The tender of the contractor who do not deposit the earnest money in the prescribed manner shall be summarily rejected. Conditional tenders /tender without earnest money will summarily be rejected. However the Executive Engineer reserves the right to reject any or all the tenders without assigning any reasons. The offer of the tender shall be kept open for **120 days** .1% labour cess shall be deducted from every running bill in addition to security, income tax and sale tax.
