The application for the issue of tender forms will be received up-to **10:00 AM to 4:00 PM** up-to **26-06-2020**. The form can also be downloaded from Departmental Web site www.hpJSV.org

The tender shall be submitted in two envelopes as prescribed in the conditions given under clause 5 of form PWD-6 as appended with schedule of quantity. The terms and conditions must be accompanied by earnest money as specified below in the shape of National Saving Certificate/Time Deposit Account/Post Office saving account in any of the post office H.P. duly pledged in the name of the XEN JSV Division Jubbal.
