Sealed item rate tenders on form 6 & 8 for the following works are hereby invited on behalf of the Governor of H.P. from the contractors/firms of appropriate class registered with Himachal Pradesh Jal Shakti Department, so as to reach in the office of the Executive Engineer, JSV Division, Rohru on **30-11-2021** upto 11.00 AM. and tender shall be opened on the same day at 11.30 AM. in the presence of the intending contractors/firms or their authorized representatives who may wish to be present. The tender forms can be obtained from this office against cash payment (non-refundable) during working hours upto **29.11.2021** upto 2.00 PM. No tender form shall be issued by post. The form can also be downloaded from Departmental website www.hpiph.org.in.

The earnest money in the shape of National Saving Certificate/Time Deposit account and Post Office saving account in any Post Office in Himachal Pradesh duly pledged in favour of the Executive Engineer, JSV Division, Rohru must accompany each tender. The contractor who has obtained exemption for depositing earnest money must attach a copy of exemption documents with their offer. The conditional tender and tenders received without earnest money will be summarily rejected. If holiday declared by the Government on the above date due to some reason, the tender shall be received and opened on the next working day. The Executive Engineer reserves the right to reject the tenders without assigning any reason. The tender form will only be issued on the production of registration certificate in the prescribed manner. The tender documents sent should be in two sealed cover in prescribed manner. The contractors are advised to see work site and read the conditions carefully before tendering. The offer of the tender shall be kept open from the date of opening of tender is 120 days. The rates are quoted both in words and figures.
