

NOTICE INVITING TENDER

Sealed item rate tender on PWD form 6 & 8 and sealed lump sum tender on PWD form 12 are hereby invited by the Executive Engineer, I&PH Division, Fatehpur on behalf of the Governor of Himachal Pradesh for the following works from the Eligible Contractors/ Firms enlisted with HPIPH Department so as to reach in this office **on or before 16.09.2019 up to 11.00 AM** and will be opened on the same day **at 11.30 AM** in the presence of intending contractors/ Firms or their authorized agents who may like to be present. The tender forms can be had from the office of the Executive Engineer, I&PH Division, Fatehpur against cash payment (Non-Refundable) which can be applied **up to 5.00 PM on or before 12.09.2019**. The Notice Inviting Tender form along with schedule of quantity is on the Departmental website www.hp.iph.org which can be downloaded. The Firms/ Contractors who downloaded the tender form from the website shall deposit the cost of tender form along with other eligibility criteria in a separate sealed cover **up to 3.00 PM on 13.09.2019**. The rates in the tender form will be filled in both in figures and words failing which the tender will be summarily rejected. The earnest money in the shape of FDR/ NSC duly pledged in favour of the Executive Engineer, I&PH Division, Fatehpur should be attached with each tender case. The conditional tenders or tender received without earnest money will summarily be rejected. The Executive Engineer reserves the right to reject the tender without assigning any reasons. The option of the tenderer shall be kept open for 120 days. If, it happens to be holiday in the office on the date of issue of tender forms/ receipt of tenders/ opening of tenders, the same shall take place on next working day.

TERMS AND CONDITIONS

1. The application for issue of tender form will be entertained **up to 12.09.2019** along with cost of form and tender form and the same will be issued **on 13.09.2019 up to 3.00 PM** against application received till **12.09.2019 up to 5.00 PM**.
2. The tenders received without earnest money will summarily be rejected.
3. Copy of the valid exemption letter, in case, the Contractor/ Firm has deposited lump sum amount with the Engineer-in-Chief/ Chief Engineer/ Superintending Engineer of IPH Department. He will be exempted from payment of earnest money in individual case for the work allocated in different parts of the State at the time of tendering. This facility will be limited to two times of the deposited amount in single or more tenders. If the Contractor/ Firm has already availed this facility, he has to deposit the earnest money up to the balance amount up to the limit, it falls short of requirement of the bid after adjusting the limit of the double the amount deposited through online (e-payment) or offline. However, in the event of acceptance of tender, the Contractor/ Firm shall have to deposit the amount equivalent to the earnest money in the prescribed manner before issue of the award letter.

In the event of availing EMD exemption facility, the Contractor/ Firm is required to upload scanned copy of affidavit duly attested by Notary/ Oath Commissioner regarding number of tenders in which the Contractor/ Firm is participating and total value of the earnest money involved. **In case of giving false affidavit/ information, the offer of the Contractor/ Firm will be liable to be rejected summarily and the Contractor/ Firm shall also be blacklisted.**

4. The Contractor shall accompany his Enlistment/ Renewal and latest Income Tax Return (Assessment Year 2018-19 or 2019 -20, Registration of EPF and GST with his application to obtain the tender documents.
5. **In respect of work at Serial No. 2, only the contractors/firms having good experience in construction of reinforced concrete hydraulic structures need submit their offers along with list of works of similar nature already completed by them.**

6. The tender form shall be issued to only those Contractors/ Firms who are found eligible attaching all the above documents.
7. The work shall be executed as per BIS/HPIPH/HPPWD specifications.
8. Corrigendum/Addendum/Corrections, if any will be uploaded on the departmental website.
