3.	TA/DA	He shall be entitled to TA/DA as per admissibly to the Class-I officers of the State Government under the concerned Rules.
4.	Leave	The provision of CCS(Leave) Rules, 1972, shall not be applicable to the re-employed pensioner and he will also not be entitled to LTC/Home Town LTC facility. However, he will be entitled to one casual leave for each completed month.

5.	Medical Facilities	He shall be entitled to avail Medical facilities and grant of reimbursement of medical expenses as admissible to Class-I officers of the State Government.
6.	Residential Accommoda -tion	He shall be antiched
7	Gratuity and Death- cum- Retirement Gratuity	He shall not be eligible for Gratuity and Death-cum- Retirement Gratuity for the period of the re-employment.
8	Other facilities	He shall be entitled to all perks and facilities as is admissible to Class-I Officers of the State Government.
