NOTIFICATION

The Governor, Himachal Pradesh, is pleased to re-employ Shri Sher Singh Dhiman, retired as Executive Engineer in the IPH Department for a period of six months, with immediate effect in the public interest.

The terms & conditions of re-employment of the above Officer will be as under-

1.	Salary	He shall draw salary in the pay scale of Rs. 15600-39100+Rs. 5400/-Grade Pay and his pay shall be fixed in accordance with the provisions contained in the HP State Civil Services (Fixation of pay of Re-employed Pensioners) Orders, 1998 circulated by the Finance Department vide O.M. No. Fin(C)B(7)-10/84 dated 01-12-1998, O.M. No. Fin(C)-B(7)-10/98 dated 8 th September, 1999 and read with O.M. No. Fin(C)-B(2)-13/2009 dated 19.04.2010, or as amended from time to time.
2.	Tenure	The tenure of re-employment shall be for a period of <u>six(06) months.</u> i.e. from the date of joining. Provided that the Government can terminate this appointment even before the expiry of the above period by serving a notice of one month in advance or by paying one month's salary in lieu of notice of one month, in case the conduct and performance of the incumbent is not found satisfactory or if the Government decides to fill up the post, in question, by regular appointment, as the case may be;
3.	TA/DA	He shall be entitled to TA/DA as per admissibly to the Class-I officers of the State Government under the concerned Rules.
4.	Leave	The provision of CCS(Leave) Rules, 1972, shall not be applicable to the re-employed pensioner and he will also not be entitled to LTC/Home Town LTC facility. However, he will be entitled to one casual leave for each completed month.

5.	Medical Facilities	He shall be entitled to avail Medical facilities and grant of reimbursement of medical expenses as admissible to Class-I officers of the State Government.
6.	Residential Accommodation	He shall be entitled to the allotment of Government Residential Accommodation, if the accommodation is available for otherwise, he will be entitled to receive House Rent Allowance as per State Government rules and instructions, in this regard.
7	Gratuity and Death-cum-Retirement Gratuity	He shall not be eligible for Gratuity and Death-cum-Retirement Gratuity for the period of the re-employment.
8	Other facilities	He shall be entitled to all perks and facilities as is admissible to Class-I Officers of the State Government.


