

PROCEEDING OF THE MEETING HELD UNDER THE CHAIRMANSHIP OF ENGINEER-IN-CHIEF, ER. R.K. KANWAR IN JAWALAMUKHI AREA ON DATED 10TH MAY, 2015.


A meeting was held at Jawalamukhi on 10.05.2015 and the following were present:-

In the said meeting, all the members were stressed upon the need to complete all the ongoing water supply scheme and Irrigation Schemes in time, so as to benefit the consumers at the earliest in pursuance to fulfillment of manifesto of the State Govt. in letter and spirit. He also stressed upon to maintain the quality of work simultaneously as per specifications. Thereafter, he suggested to all the field functionaries to be fully prepared for tackling the drought during the ensuing summers by taking following measures.

- i) All the leakage of pipelines be plugged in a war footing manners.
- ii) All the sources and sector storages tanks of various water supply schemes be cleaned periodically preferably on the day of cut of electricity in consultation with electricity Department and leakages be plugged simultaneously on the same day as supply lines shall be dry then. Advance intimation to public be given through local newspaper to this effect, so as to avoid inconvenience to the consumers.
- iii) Proper chlorination of all Water Supply Schemes be done and fix responsibility of person by name ,designated for this purpose scheme wise.
- iv) In summers kitchen gardening should be strictly discouraged by sudden checks by the teams formulated for this purpose involving PRI's of Panchayats in such teams in addition to Departmental staff.
- v) The consumers especially commercial consumers be motivated to get the water meters installed so that misuse of potable water could be minimized and simultaneously more


revenue could be generated and also media be involved to create awareness in this regard so that consumers voluntarily get metered connections
