

provision of Rule-25.



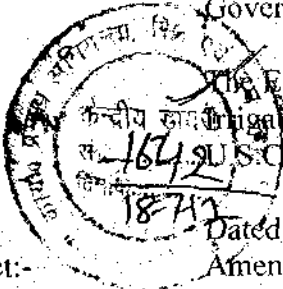

Sir,

In continuation to this department Notification of even number dated 29.10.2013 on the subject cited above, I am directed to say that with a view to widen the scope of competition in a fair manner and to extend the scope of entry of Contractors/firms having appropriate specialization in the tender process of IPH Department, Rule-24 of the Rules of Enlistment of Contractors in Himachal Pradesh, IPH Department, 2013 is hereby amended below by invoking the provision of Rule-25 of Rules ibid:-

**Rule- 24**

**"Definition of Works:-**

1. Water Supply Schemes;
2. Irrigation Schemes;
3. Flood Protection Works;
4. Sewerage Schemes;
5. Hydro electric Power Projects;
6. Civil Works of PWD/Municipal Corporation/CPWD etc.;
7. Hand Pumps and Borewells/ Tubewells;

Only the Contractors who have secured above works of appropriate magnitude in State/CPWD, Irrigation Department, Public Health Department, PSU's, and Autonomous bodies of Central & State Government shall be considered for enlistment & revalidation." All other aspects of the said notification dated 29.10.2013 and amended dated 11.07.2016 will apply.
