And whereas, as per the instructions of Finance Department dated 27.09.2012, the Superintending Engineer, Jal Shakti Circle, Kasumpati, Shimla-9 has also granted the Grade Pay of Rs. 6600/- to Sh. Umesh Kumar Dogra, Assistant Engineer (Retired) on completion of 20 years of regular service as Junior Engineer w.e.f. 01.10.2012.

And whereas, the four tier pay scale of Pay Band of Rs. 15600-39100/- + Grade Pay of Rs. 6600/- on completion of 04 years service granted to Sh. Umesh Kumar Dogra, Assistant Engineer (retired) w.e.f. 01.01.2018 was withdrawn vide this Department's Notification of even number dated 21.10.2021 in view of the instructions of Finance Department issued on 27.09.2012.

And whereas, as per the Finance Department's Notification No. FIN(PR)B(7)-1/2021 dated 3rd January, 2022, the pre-revised pay structures, the Assured Career Progression Schemes were applicable to various categories of State Government employees circulated on 27.09.2012, the benefit of existing ACPS/4-tier/3-tier/two tier pay scales/structures allowed to the various categories would not be admissible on or after the date of notification of HP Civil Services (PR) Rules, 2022 i.e. 3rd January, 2022 and the Grade Pay of Rs. 6600/- as was granted to Sh. Umesh Kumar Dogra, Assistant Engineer (Retd.) w.e.f. 01.12.2012 on completion of 20 years service as Junior engineer has also been withdrawn by the Superintending Engineer, Jal Shakti Circle, Kasumpti, Shimla-9 vide office order No. JSCS-EA-II-Revison of pay scale/2021-22-4943-51 dated 26.08.2022

And whereas, Shri Umesh Kumar Dogra, AE (Retired) has filed a CWP No. 2980/202 titled as Umesh Kumar Dogra Vs. State of H.P. & ors and the

Hon'ble High Court vide order dated 04th April, 2024 has afforded last opportunity to file reply in the matter.

And whereas after going through all the relevant records as well as the instructions issued by the Finance Department from time to time it has been observed that the benefit of 4 tier pay scale already awarded to Sh. Umesh Kumar Dogra is required to be restored.

Now therefore, the benefit of four tier pay scale of Rs. 15600-39100/- + Grade Pay of Rs. 6600/- (Pre-revised) withdrawn by the Govt. on 21.10.2021 is hereby restored as under:-
